Katten Assisting “Rooftop Pastor” in Efforts to Transform Chicago Community Plagued by Violence

Pastor Corey Brooks made headlines earlier this year after he spent 94 days in the dead of winter atop the roof of an abandoned motel adjacent to his church in the Woodlawn neighborhood on the South Side of Chicago, in an effort to raise \$450,000 to purchase and demolish the building, which had become a haven for crime and drugs. His campaign, called [Project H.O.O.D. \(Helping Others Obtain Destiny\)](#), was a success—thanks in part to a \$100,000 donation from Tyler Perry on day 90—and the building came down on March 27. But that was just the beginning for Pastor Brooks. The “Rooftop Pastor” recently embarked on a nearly 3,000-mile walk across America to call attention to the violence plaguing Chicago and to raise \$15 million to build a state-of-the-art community center on the site of the old motel. The community center will provide area children and families with the same resources and activities available in more affluent neighborhoods, attacking four societal ills, as identified by Pastor Brooks—social, economic, educational and spiritual. Katten has committed to helping Pastor Brooks realize his vision.

After friends of Pastor Brooks asked **Mel Katten** to meet with him, the firm enthusiastically agreed to represent Project H.O.O.D. on a *pro bono* basis in its efforts to build the new community center. Mel, who is overseeing the firm’s work on the project and acting as a business consultant to Pastor Brooks, says he was impressed with Pastor Brooks’ approach and attitude, and that the community center could be “a game changer” for the resource-poor Woodlawn and Englewood neighborhoods. “We are greatly committed to helping Project H.O.O.D. raise the capital to start construction on the community center, something that is clearly lacking in that area,” says Mel. “There is nowhere in that three-mile range where kids can have a safe place to gather, where unemployed people or the elderly might go to receive counseling.” Chicago attorneys **Bob Wild** and **Seth Madorsky** are also involved in the project. Bob has worked on establishing tax-exempt status for Project H.O.O.D. and in developing the entity’s corporate governance policies and guidelines. Seth is handling real estate and real estate development matters.

On May 31 the firm helped Pastor Brooks kick off the [Project H.O.O.D. Walk Across America to End Violence](#) by co-sponsoring a pre-walk fundraising celebration along with leading architecture firm Perkins+Will, which will be designing the new community center *pro bono*. Accompanied by his two sons, Cobe, 11, and Desmond Marshall, 22, Pastor Brooks began his cross-country trek in New York’s Times Square on June 5 and expects to reach the Staples Center in Los Angeles on September 28, stopping in several major cities along the way.

Los Angeles Attorneys Achieve Hard-Won Victory for Brothers Facing Deportation

After more than five years, Katten clients Wilsor and Eduin Romero-Inestroza, brothers from Honduras, have been granted asylum pursuant to the Trafficking Victims Protection Reauthorization Act of 2008 (TVPRA). Los Angeles litigation partner **Kristin Holland** and associates **Gloria Franke**, **Sara Karubian** and **Meegan Maczek** have represented the Inestrozas throughout the asylum process.

Wilsor and Eduin were born in Honduras and eventually abandoned by their parents. In 2005, when Wilsor was 12 and Eduin was 9, their mother left Honduras with their younger sister. Their father then left them with their uncle and cousins, who were physically abusive toward the boys. After enduring many months of abuse, the boys' cousin drove them to the Honduras/Guatemala border. Wilsor and Eduin then traveled for one month alone through Mexico and in May 2006 were detained while attempting to cross the border into the United States near Brownsville, Texas. The boys were sent to live with their uncle in Lancaster, California, where they continue to reside.

Katten began representing Wilsor and Eduin in March 2007. In July 2007, the boys missed a hearing because their guardian could not provide transportation. As a result, the Immigration Court issued a deportation order. Wilsor and Eduin filed a motion to reopen the removal proceedings, which was denied. They then appealed that decision to the Board of Immigration Appeals (BIA).

While their appeal was pending, the TVPRA was signed into law. Although the TVPRA was primarily aimed at preventing and prosecuting human trafficking, it did change the filing procedures for unaccompanied alien children (UACs) filing for asylum. Prior to the enactment of the TVPRA, UACs would typically defensively file their Form I-589 Applications for Asylum with the Immigration Court in removal proceedings. Section 235(d)(7)(B) of the TVPRA changed this procedure. UACs now file their Form I-589 Applications for Asylum with the U.S. Citizenship and Immigration Services (USCIS), which has initial jurisdiction over asylum applications of UACs.

The enactment of the TVPRA proved advantageous for Wilsor and Eduin. In April 2009, the BIA issued an order remanding their case back to the Immigration Court to determine whether Wilsor and Eduin were subject to the initial jurisdiction provision of the TVPRA, which would allow them to file asylum applications before the USCIS. The Immigration Court determined that Wilsor and Eduin were subject to the initial jurisdiction provision of the TVPRA and stayed their removal proceedings. They submitted Form I-589 Applications for Asylum with the USCIS in June 2011 and were interviewed by an asylum officer in August 2011.

Wilsor and Eduin were granted asylum in April 2012 and their removal proceedings were terminated in June 2012. They both reside with their aunt and uncle in California. Eduin, now 15 years old, will begin high school in the fall. Wilsor, now 18, just graduated from high school and will attend community college in the fall.

Katten Receives Outstanding *Pro Bono* Contribution Award from Law Center to Prevent Gun Violence

Katten was honored with an Outstanding *Pro Bono* Contribution Award for its work in support of gun violence prevention at the [Law Center to Prevent Gun Violence](#)'s (LCPGV) 19th Anniversary Dinner on June 14. The award recognizes the efforts of Chicago litigators **Jonathan Baum**, **Jonathan Feld**, **Bonita Stone**, **Sharyn Castle** and **Jessica Price**, who represented LCPGV as *amicus curiae* in *Wilson v. Cook County*, a case before the Illinois Supreme Court involving a Second Amendment challenge to Cook County's ban on assault weapons and large capacity ammunition magazines. The team filed a brief on behalf of LCPGV that was joined by the City of Chicago, the Major Cities Chiefs Association and the Association of Prosecuting Attorneys. Based in San Francisco, LCPGV is the only national law center focused on providing comprehensive legal expertise in support of gun violence prevention and the promotion of smart gun laws that save lives.

Charlotte Attorneys Join Call 4ALL Pro Bono Legal Services Program

The North Carolina Bar Association Foundation has partnered with Legal Aid of North Carolina (LANC) to create [Call 4ALL](#), a new *pro bono* program that gives attorneys the chance to assist low-income individuals who qualify for legal aid, but cannot be served because of severe budget restrictions on North Carolina's legal aid entities. Call 4ALL volunteer attorneys provide advice or discrete services to pre-screened LANC clients in areas of law including private landlord/tenant, public and subsidized housing, Medicaid, disability and non-disability issues in Social Security matters, consumer collections, employee rights, custody, guardianship and simple estates. Volunteers are asked to commit to accept just one or two one-hour calls per month from LANC clients. The program offers a structured way for attorneys to meet their *pro bono* service goals within a limited scope of engagement, while providing essential assistance to LANC clients. LANC will even provide substantive law training as needed and may offer group training sessions that would allow volunteers to receive free CLE hours. Katten Attorneys Run for Charity on Both Coasts

Katten will be honored at Public Counsel's Annual *Pro Bono* Awards Reception on July 24 for its participation in the 2012 Run for Justice in Los Angeles. The firm took first place for Outstanding Team Participation and second place for the Karen Paull Justice Cup, awarded in recognition of the most money raised. Held in conjunction with the Los Angeles Marathon, the annual Run for Justice helps raise funds in support of Public Counsel, the largest *pro bono* law office in the country.
