Helping Protect the Affordable Housing Engine for the Los Angeles Region

Katten has teamed with Public Counsel, the Public Interest Law Project, the Southern California Association of Nonprofit Housing and other nonprofit housing groups to preserve an important source of funding for affordable housing in the Los Angeles region—the City of Industry Funds.

The City of Industry Funds consist of tax increment funds collected by the city’s redevelopment agency and transferred to the housing authority to administer for the development of low- and moderate-income housing. Since the program began in the mid-1990s, Industry, which has no zoning for new housing, had been giving its redevelopment agency’s low-income housing money away to other communities. More than \$200 million from the City of Industry Funds had been allocated for the development of more than 10,000 units of affordable housing.

California’s redevelopment agencies were eliminated as part of a cost-saving measure by the state last year. However, the law which dissolved the redevelopment agencies requires “successor agencies” to fulfill the legal obligations of the former agencies.

Los Angeles real estate partner **Allan Abshez** and special counsel **Elizabeth Camacho** drafted and submitted a petition urging the oversight board of the now-dissolved redevelopment agency to place these obligations on the Recognized Obligation Payment Schedule (ROPS), which is the list of all obligations the former redevelopment agency is required to pay as it unwinds. On August 7, after hearing testimony from Public Counsel and Katten lawyers, the oversight board voted unanimously to recognize the payment and include it on the ROPS.

While the California Department of Finance must still approve the payments, Katten and Public Counsel will continue their efforts on behalf of the nonprofit developers who rely on the City of Industry Funds to ensure that the state complies with the law and protects these desperately needed funds.

Enforcing “I Am That Girl”'s Trademark Rights

Chicago intellectual property partner **Floyd Mandell** successfully resolved a trademark dispute on behalf of the [I Am That Girl](#) Foundation, a charitable organization that assists young women throughout the world living in impoverished conditions and/or escaping abusive relationships. The Foundation provides educational and other resources to help them establish self esteem and build community through the Foundation’s online network of positive media. Floyd assisted the Foundation, which owns the trademark rights to “I Am That Girl,” including for t-shirts, in getting Nike, Inc. to cease using the phrase “I’m That Girl” on t-shirts produced by the company.



Katten Honored by Constitutional Rights Foundation

Katten has been named Firm of the Year by the [Constitutional Rights Foundation](#) (CRF), a Los Angeles-based nonprofit, nonpartisan organization dedicated to educating America's young people about the importance of civic participation in a democratic society. Inspiring Words

In accepting her Pro Bono Service Award, **Monica Mosby** reminded us that, “Being afforded the opportunity to get a legal education is a blessing. To be able to share this blessing with others is an honor.” Monica continued:

I grew up in an area only a few miles west of this office...the “West Side.” Nearly all of my friends lived in public housing projects. We didn't have a lot of money—I was raised by my mother and grandmother; I attended the neighborhood public school where, at that time, 99% of the students tested below the state average on the standardized test...There are so many other paths that I could have taken—paths that perhaps could have led me to be in a position of needing pro bono assistance, as opposed to being able to provide it.

It is because of this that pro bono work is important to me—I know that it could be me on the other side of the table. And that is something that all of us in this room share and should remember, especially given this latest recession that has found many of our friends out of work. For this reason, as well as many others, pro bono work should be a part of each and every one of our practices, our lives, whether it is providing legal services or handing out food baskets at your neighborhood pantry.

Washington Office Teams Up with Federal Public Defenders

Since 2009, attorneys in the Washington office have participated in the Pro Bono Counsel Program of the Federal Public Defender's Office for the Eastern District of Virginia (FPD-EDVA). Attorneys participating in the program team with one or more attorneys from the FPD-EDVA to serve as co-counsel for indigent defendants facing criminal charges in the federal district court in Alexandria, Virginia. Katten attorneys participating in the program have represented criminal defendants facing a variety of charges ranging from mortgage and wire fraud to firearms possession and terrorism, none of whom have the resources to hire an attorney. As part of the program, firm attorneys have assisted the FPD-EDVA in conducting investigations and witness interviews, drafting and filing motions, and arguing sentencing and other issues before the court.

In the past year, partner **Kristine Rembach** and associates **Christopher Jackson**, **Jennifer Loeb** and **Robert Smith** have participated in the program, providing much-needed legal services to indigent defendants and support to the Federal Public Defender's Office, while at the same time gaining practical knowledge and in-court experience.

Chicago Office Participates in 19th Annual Race Judicata

A team from Katten's Chicago office joined thousands of other runners on September 13 for Race Judicata® 2012, a 5K Run/Walk along a scenic lakefront course benefiting [Chicago Volunteer Legal Services Foundation](#), which works to provide legal services to the poor and working poor of Chicago. 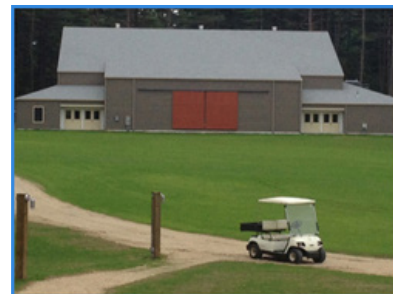
Pioneering Scholarship in Animal Rights

Chicago litigation associate **Blake Mills** has been assisting the [Nonhuman Rights Project](#) with research in connection with the organization's efforts to change the way our law currently categorizes animals. As part of that research, he was asked to draft an article about the use of the writ *de homine replegiando*, which is similar to the writ of *habeas corpus*, to challenge an illegal detention. The article examines how this writ has been previously used by petitioners that the law considered "things" to seek a court determination that they should instead be considered legal "persons" entitled to the right to bodily liberty, and whether the writ remains viable today.
