She also took the lead in successful litigation that required two insurance companies to advance defense costs and fees for the benefit of her clients and numerous other parties. In April 2008, in a non-Refco matter, Ms. Kim secured a victory in an apparent case of first impression

involving a corporate control dispute under California Corporations Code Section 709 by obtaining an order removing a director that had attempted to usurp control over a closely held corporation and appointing new interim directors for the corporation.

Ms. Kim is also recognized as a leader in the Los Angeles legal community. She is a member of the Los Angeles County Bar Association's board of governors and serves on its Judicial Appointments Committee. She is president-elect of the Women Lawyers Association of Los Angeles and chair of the board of the Korean American Coalition's Los Angeles Chapter, a nonprofit community advocacy organization serving the Korean-American community. Ms. Kim is also active in several national organizations. She serves as co-editor of the ABA Litigation Section's *Securities Litigation Journal*. She also serves on the ABA's Commission on Racial and Ethnic Diversity in the Profession and is a member of Katten's Committee on Racial and Ethnic Diversity. She is the immediate past president of the National Asian Pacific American Bar Association.
