REOPENING OF TEXAS HEALTH CARE PROVIDERS

Many of the reopening requirements are based on representations that the providers' services will not reduce the available personal protective equipment (PPE) needed to respond to the COVID-19 crisis despite the fact that PPE is necessary to ensure the safety of the physicians, nurses and other staff.
